<p>JUDGES AND JUDGES' PANELS</p>	<p>Competitions will be evaluated by two Judges' Panels as follows:</p> <ul style="list-style-type: none"> • 4 Difficulty (D) Judges (min. cat. 2) • 6 Execution (E) Judges (min. cat. 3) • 2 Line (L) and 1 Time (T) Judges (min. cat. 4) <p>Priority will be given to the highest categories.</p> <p>The Judges' Panels are set up by a draw from the judges present at the event. The draw will be directed by the RG Technical Delegate.</p> <p>The participating member federations must send minimum one qualified judge if they participate with individual gymnasts and one qualified judge if they participate with a group. Those judges can be the same or different.</p> <p>The Organizing Member Federation is responsible that there are enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the online nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.</p> <p>Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation.</p> <p>The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge (to be paid to the LOC by 04 April 2019) should a federation fail to bring the required number of judges or judges without the requested qualification (brevet).</p> <p>Note: Judges are allowed to watch the Podium training session from the delegation seating only</p>

The Organizing member Federation shall determine the hotel at its discretion but may not choose the "low cost" category hotel for the above-mentioned gymnasts.

The costs for the accommodation must be paid to the LOC as follows:

- deposit of 50% of the total due amount by **05 February 2019**
- settlement of the remaining 50% by **05 March 2019**

Definitive Registrations not accompanied by the deposit of 50% will be considered as invalid and will be refused.

In case of cancellation, costs will be refunded as follows:

- before 18 March 2019: 50% of the total amount due
- from 18 March 2019: no refund the total amount due

While the **Accommodation Form** must be returned to the LOC by **05 February 2019** at the very latest, the Hotel rooms will be allocated on a "first come, first serve" basis.

The prices charged for the hotel rooms cannot exceed the usual hotel rates.

After the deadline (05 March 2019), a **change request** has to be submitted to the LOC in written form. A fee of **€ 20.00** will then be charged per change request. Fees for changes request are in addition of cancellation costs.

Names changes as allowed in the FIG Technical Regulation cannot be fined.

MEALS

The invited participating federations must pay for the meals expenses of their delegation members, except for the below mentioned gymnasts for whom meals will be paid by the LOC (from the official arrival day to the official departure day):

- The top three (3) gymnasts in the All-Around ranking from the 2018 Sofia World Championships present at the event
- The top three (3) Groups in the All-Around ranking from the 2018 Sofia World Championships present at the event

The meals will be served as follows:

- Lunches: **ONLY** in a site inside the Adriatic Arena. The coupons must be ordered and paid to the LOC.
- Dinners: **ONLY** in the booked hotel

The costs of the meals are per person and per meal: **lunch € 25.00 / dinner € 25.00.**

The **Meals Form** must be returned to the Organizing Member Federation and to the LOC by **05 February 2019** at the very latest.

The **100% of the costs** for the meals must be paid to the LOC **within 05 March 2019.**

In case of cancellation costs will be refunded as follow:

- Before 18 March 2019: 50% of the total amount due
- After 18 March 2019: no refund the total amount due

After the deadline (5 March 2019), a **change request** has to be submitted to the LOC in written form. A fee of **€ 20.00** will then be charged per change request. Fees for changes request are in addition of cancellation costs.

FINAL BANQUET	<p>The Final Banquet will take place on 07 April 2019. The tickets of the Final Banquet (€ 20.00/person) must be paid to the LOC by 05 March 2019. Only Delegations (accredited members) and invited persons can participate.</p>
INTERNATIONAL TRANSPORTATION	<p>The invited participating federations must pay for the International travel costs of their delegation members. The Travel Schedule Form must be returned to the Organizing Member Federation and to the LOC by 18 March 2019.</p>
LOCAL TRANSPORTATION	<p>Local transportation costs will be covered by the LOC. The LOC will take in charge transportation costs for all accredited people from the airports of Ancona (40 minutes from Pesaro), Rimini (40 minutes from Pesaro) and Bologna (120 minutes from Pesaro) to hotels, and from hotels to Adriatic Arena (and vice – versa), <u>only if hotel reservations are made through the LOC.</u></p> <p>The LOC recommends Rimini or Ancona as airports of arrival and departure. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.
